**Annex 2 – Conditions consistent with the Operating Schedule**

**Existing Condition 9:** Any alcohol to be consumed in the outside area must be decanted into shatterproof drinking vessels.

**Replacement Condition 9:** Any alcohol to be consumed in the outside area must be decanted into shatterproof drinking vessels, except bottles no greater than 330mls in volume.

**Existing Condition 13:** No drinks or food to be consumed in the Designated Smoking Area after 01:30.

**Replacement Condition 13:** No drinks or food to be consumed in the Designated Smoking Area after 02:00 Sunday – Thursday and 02:30 Friday and Saturday.

**Existing Condition 14:** Any external drinking areas must be closed to Patrons from 01:30 Monday to Sunday, except for a Designated Smoking Area, the size and location of which must be agreed with the Environmental Health Pollution Team.

**Replacement Condition 14:** Any external drinking areas must be closed to Patrons from after 02:00 Sunday – Thursday and 02:30 Friday and Saturday, except for a Designated Smoking Area, the size and location of which must be agreed with the Environmental Health Pollution Team.

**Existing Condition 24:** The smoking area will consist of three tables which will be surrounded by barriers and will be monitored.

**Replacement Condition 24:** The smoking area will consist of eight tables which will be surrounded by barriers and will be monitored.

**Existing Condition 31:** Regulated entertainment shall not be provided at any time that the doors of the ground floor façade are open.

**Replacement Condition 31:** Regulated entertainment may be provided when one of the ground floor façade doors are open on the basis that any noise from regulated entertainment shall be inaudible within any noise sensitive premises which includes any dwelling that has one or more windows open. A test of fulfilment of this condition shall be that noise from the premises is no more than barely audible at the boundary of any nearby sensitive premises. On each day that regulated entertainment takes place the Designated Premises Supervisor shall ensure that a test for fulfilment of this condition takes place on at least 2 occasions.

**Additional Condition to be added to Licensing Operational Schedule:** No person under the age of 18yrs will be permitted entry into the premises.

#### **The prevention of crime and disorder**

- Anjelique Bar will employ an additional SIA Doorman on Friday and Saturdays to monitor the outside drinking area.
- SIA Door Team will have Body Worn Cameras.
- Patrons will be required to be seated at socially distanced tables and table service will be provided.
- All alcohol consumed in the outside area will be decanted into shatterproof drinking vessels.
- The area is cordoned off via barriers.
- CCTV monitoring the full area.
- All bottles and glasses are to be removed from public areas as soon as the contents have been drunk or are empty.
- Bottle bins for collection or empty bottles will not be accessible to members of the public.

#### **c) Public safety**

- Capacity will be limited to 50 patrons.
- All staff members have been trained in fire and emergency evacuation procedures.
- The manager will perform periodic noise checks outside the building on all sides, with specific attention to those sides closest to residential properties.
- 24 hour recorded CCTV
- Only shatterproof glasses to be used
- Anjelique Bar will employ an additional SIA Doorman on Friday and Saturdays to monitor the outside drinking area.
- Customers will be registered on an I.D Scanner that enter the Anjelique Bar premises.

#### **d) The prevention of public nuisance**

- Staff will encourage customers to engage in the outdoor area quietly, recognizing the needs of local residents and businesses.
- The licensee shall ensure that prominent clear and legible notices are displayed at all exits requesting customers to leave the premises and the area quietly.
- Regular sound checks to be performed.

## **Notes for Guidance**

This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.

1. **You do not have to pay a fee** if the only purpose of the variation for which you are applying is to avoid becoming liable for the late-night levy
2. **Describe the premises.** For example, the type of premises, its general situation and layout and any other information which could be relevant to the licensing objectives.   - **Indoor sporting events:** no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
  - **Boxing or Wrestling Entertainment:** no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
  - **Live music:** no licence permission is required for:
    - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
    - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
    - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
    - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
    - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
  - **Recorded Music:** no licence permission is required for:
    - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.

- any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
  - **Dance:** no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
  - **Cross activity exemptions:** no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
    - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
    - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
    - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
    - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
