The event 'High Street Live' will take place outdoors on Crawley High Street, with a road closure in place from the junction with Peglar Way at south end, and at the north (Jubilee Oak) end at the junction with Bank Lane.

The High Street will be closed from 06.00 to 23.00 on Saturday 30 September and two small stages will be erected, taking account of existing street furniture. The Gatwick Airport Stage will be located at the southern end of the High Street opposite to the junction of Ifield Road and the former ASK Italian and the Crawley BID Stage will be located at the northern end of the High Street adjacent to the phone boxes.

At the Gatwick Airport Stage back entrance will be a marquee which will house event control and a small artist changing area. The event control will be manned throughout the event, and will restrict access to the backstage area.
