A personal licence holder will be at the premises at all times when alcohol is being served and we will provide food and alcohol that is available at all times when the premises are open.

A C.C.T.V system will be installed and recordings will be maintained for an appropriate period of time to be agreed with the police and the Licensing Authority.

c) Public safety

Adequate and appropriate First Aid equipment and materials will be available at the premises. Fire safety sign, Fire Safety Certificate, gas & electric certificate and Public liability insurance certificate will be obtained each year & displayed at the premises.

d) The prevention of public nuisance

Noise or vibration from premises will be maintained at low level and recorded music will be played inside the premises only. The premises are air-conditioned to avoid the need to open doors & windows for ventilation.

e) The protection of children from harm

Alcohol is not available on the premises when only under 18's are permitted. The premises will be operating a proof of age policy.
