Creative Crawley is bringing an existing performance of Astrology Bingo to Crawley as part of the Give It A Go season 23-24. Part cabaret, part game show, the performance of Astrology Bingo has been performed numerous times across the country.

"Your favourite galactic gal pals Figs in Wigs have created Astrology Bingo - the world's first ever* cosmic game show for astrology lovers, bingo wingers and their sceptic friends. "

Audience members are invited to play bingo and watch various cabaret like performances over a two hour running time. The doors open for audience to arrive at 19:00 with the performance starting at 19:30 and then ending at 21:30.

Creative Crawley will host the event and invite audience to attend the sit down performance. This is a ticketed event and will have a maximum capacity (including staff) of 85.

Creative Crawley will work with Posh Club, who will be running a bar for the event serving a bespoke offer of prosecco and soft drinks. Posh club will also provide crisps and small snacks

Creative Crawley will ensure there are two security guards on duty for the duration of the performance.

Creative Crawley will employ up to three FOH staff to help manage audience members.

In total there will be 6 staff members on hand to ensure the smooth running of the event (Box office, FOH staff, Duty Manager and Event Manager)

One free drink (soft or prosecco) will be offered to all ticket holders. After this, a cash bar will be in operation.
